Further, member(s) agree and understand the Northern Kentucky Skating Club, its administrators, agents and assigns, are not responsible for any medical and emergency expenses incurred by any member(s) in the event of any injury or illness arising out of the use of any skating facility. By signing this Release, each adult agrees to its terms for himself/herself and every child member that he/she is responsible for as a parent or guardian.

Fundraising Obligation:

I understand that in addition to the membership dues, there is a fundraising obligation of \$90.00 for the initial Full Competitor member and \$25.00 for each Additional Full Competitor member; \$45.00 for the initial Junior member and \$15.00 for each Additional Junior member; with a maximum of \$180.00 per family. The fundraising obligation is due at the beginning of each club year. Any fundraising done during the club year will be credited against the fundraising obligation due at the beginning of the next club year. The obligation can be met by various fundraising opportunities made available by the club or by direct payment.

Proration:

Membership fees and fundraising obligations (excluding USFSA fees) are prorated by 50% for new members joining after December 31st. Due to the financial responsibilities of the NKSC, we are not able to discount membership and/or fundraising obligations for members upon exiting the club. Members needing to change membership levels during the club year, but before March 31, are responsible for the difference between their current and prospective membership levels including fundraising responsibilities.
