TEST APPLICATION

Northern Kentucky SC Test Rules and Guidelines

- 1.) All Test skaters must be members of United States Figure Skating (USFS).
- 2.) Test application must be filled in completely or it will be invalid.
 - Skater's name must be spelled plainly, the exact way that it is spelled on their USFS membership card.
 - USFS membership number must be included and correct.
 - Home club name should be spelled out completely. No abbreviations.
- 3.) Test fee(s) must be included with the test application, in the exact amount. Checks and/or money orders are payable to **NKSC**. No change will be given.
- 4.) Test skaters who are not members of NKSC must obtain an authorization to test letter from their Home Club test chair, to be turned in with the completed test application and fees, unless other arrangements have been made.
- 5.) The completed test application, along with accompanying forms and fees, must be turned in to the NKIC office **no later than one week prior to the test date**, unless other arrangements have been made.
- 6.) Test skater(s) must arrive at the rink at least one (1) hour prior to their scheduled warm-up time, in the event that the test session is running ahead of schedule.
- 7.) Skaters should check in with the ice monitor or test chair upon their arrival at the rink.
- 8.) No refunds will be given after the test application deadline date. If special circumstances apply, refunds will be given at the discretion of the NKSC test chair, pending NKSC Board approval.
- 9.) There are no test fee credits. Separate payment is required for contingency tests, in the event that the first test is not passed.
- 10.) A skater may be charged an additional fee due to increased expenses such as prime ice time, officials' transportation or lodging, etc.
- 11.) Non- member tests are accepted on the basis that there is available space in the test session to accommodate the request.
